UCC laws were set up by the non-profit organization National Conference of Commissioners on Uniform State Laws to regulate sales of personal property and other business transactions and to make it easier for businesses to work together across the U.S. Each state has its own, slightly different, version of the UCC.

### **Uniform Commercial Code - Uniform Law Commission**

The provisions of what is now UCITA were originally meant to be "Article 2B" on Licenses within a revised Article 2 on Sales. As the UCC is the only uniform law that is a joint project of NCCUSL and the ALI, both associations must agree to any revision of the UCC (i.e., the model act; revisions to the law of a particular state only require enactment in that state).

### **The Uniform Commercial Code and Contracts for the Sale of ...**

Art. 2 Sales: UCC Article 2 applies to transactions of goods; it does not apply to any transaction which although in the form of an unconditional contract to sell or present sale is intended to operate only as a security transaction nor does this Article impair or repeal any statute regulating sales to consumers, farmers or other specified classes of buyers.
